

Work-related language learning in

Finland

Majority language learning (L2) for newly-arrived migrants

State-provided integration courses for migrants last about one year. Every unemployed migrant has an individual integration plan. This is a personalized plan covering measures and services promoting Finnish/Swedish language learning ('sufficient command') and knowledge and skills required in Finnish society and working life. The plan may include integration training, basic education, vocational education, upper secondary education, studies leading to higher education, continuing education, further training. Integration policy aims to promote the integration of individuals and of family groups.

Entitlement to an integration plan extends to a maximum of three years following initial entry (with the possibility of a further two years in certain circumstances, e.g. the migrant is not literate, the migrant takes maternity/paternity leave, or suffers illness). Integration courses are state-funded. The personalised integration plan is agreed jointly by the migrant, the municipality and the employment office. The migrant is able to claim financial assistance from the state (min. 480 €/month).

Work-related L2 provision for employees/workers

Finnish language courses are offered by a range of adult education providers (including adult education centres, university language centres; summer universities, in-service training centres, private language schools). These courses are offered on a self-financing basis. In some circumstances recruitment agencies and/or employers pay for courses; in others learners pay for themselves.

Practice examples of interest

The extensive on-line learning environment, <u>kotisuomessa.fi</u> includes learning related to common occupations and essential skills needed in the workplace and also to Finnish working culture and work methods.


Work-related L2 provision in vocational courses

L2 instruction is available as a part of studies in vocational education and higher education (universities of applied sciences, universities). Where the learner is studying on a free vocational/higher education course, this L2 instruction is free. University language centres have also self-financed students attending certain courses only.

Work-related literacy provision for low-literate L1/L2 adults

Literacy courses are available as integration training; no specific work-related courses are available.





The *National core curriculum for literacy training for adult migrants* (available in the Network's <u>resource</u> <u>centre</u>) was published in 2012. Provision is state-funded.
